

## **DESIGN A NATIONAL BOOK TOKEN TERMS & CONDITIONS**

1. Entries must be sent in **before Friday 10 April 2020 only**. Entries received after this date will not be accepted.

2. Proof of postage will not be accepted as proof of entry.

3. Entries must be returned to: World Book Day Design a Book Token Competition, Book Tokens Ltd, 6 Bell Yard, London WC2A 2JR.

4. All entries MUST be accompanied by the pupil's details and the full contact details of the adult submitting the entry, as specified on the second page of the entry form. The organisers accept no responsibility for entries that are incomplete, illegible or incorrect.

5. Only one entry will be accepted per pupil.

6. Prizes will be awarded as follows: 1st Prize in each age range – £250/€295 National Book Tokens for the school,\* £100/€110 National Book Tokens for the pupil and £100/€110 National Book Tokens for the teacher.\* Runners-up Prize in each age range – £150/€180 National Book Tokens for the school,\* £50/€60 National Book Tokens for the pupil and £50/€60 National Book Tokens for the teacher.\* National Book Token prizes will be supplied in Sterling (if the winner is located in the UK) or Euros (if the winner is located in the Republic of Ireland).

7. The organisers (World Book Day Ltd and Book Tokens Ltd) will not be responsible for the loss of or damage to any entries and entries will not be returned.

8. All entries should be produced on A4 paper using the template provided.

9. All entrants should be aged up to 18 years, resident in the UK or Republic of Ireland and in fulltime education.

10. The judges' decision is final and, regretfully, no correspondence can be entered into.

11. Prizes are non-transferable, and no cash alternatives will be offered. The organisers reserve the right to amend the prizes or offer an alternative.

12. Copyright on all entries submitted will remain with the individual creators, except in the case of the three age-range winners and the overall winner, in which case, Book Tokens Ltd will require the assignment of the copyright.\*\* The fee for this assignment is inclusive in the overall prize.

13. The organisers reserve the exclusive right to inform the media of all results and details of the competition, including the winners' first names, ages and the names of their schools,

where applicable. Where the sharing of this information would present a safeguarding concern, some or all of these details may be withheld upon request.

14. By entering the competition, entrants will be deemed to have accepted the rules and conditions of the competition.

15. Employees of Book Tokens Ltd and their agencies and members of their immediate family are not eligible to enter.

16. The organisers reserve the right to cancel the competition without notice under exceptional circumstances.

\*Prizes for the school and teacher will not apply in the case of winning entries received from home-schooled students.

\*\* Subject to the winning design being suitable for use as a National Book Token, all or part of the design will be published.
